### **Job Purpose**

- To teach courses of learning, based on the requirements for the Adult Learning and Skills Sector, and act as a role model for teaching excellence and commitment to the professional standards

- To support learners, in their learning, including undertaking initial, formative and summative assessment, developing personalised strategies that ensure learners progress
- Ensure learners are given advice and information regarding progression pathways into other forms of learning and training.
- To undertake and lead curriculum development, creation of detailed Schemes of Learning and individualised session planning
- Preparation of learning materials, development of learning resources and the design and development of monitoring and assessment tools.
- To liaise with other agencies supporting learning provision in relation to the recruitment and referral of learners and where appropriate, assist directly in the recruitment and enrolment of learners.
- To contribute to the administration of learning programmes including fee collection and the completion and return of course data.
- Development and delivery of RARPA systems and contribution to moderation and standardisation practices
- To support quality monitoring and improvement through participating in observation of teaching and learning, the analysis of performance data, service wide self-assessment and inspection.
- To undertake leadership of a course or curriculum/subject area, including offering curriculum support, guidance and sharing good practice learning with colleagues.
- To participate in and where appropriate lead Staff Development opportunities to increase best and safe practice that meet the quality requirements of the service, funding agencies and awarding bodies.
- Actively participate in CPD activity and practice that upholds and embeds the Education and Training Professional Standards
- To participate in the city council's performance management and appraisal systems, including the appraisal of others.
