WHAT DOES A STUDY PROGRAMME LOOK LIKE?

IF YOU REQUIRE MATHS & ENGLISH

(Achieved below a 4 at GCSE for both - evidence will be required)

You will attend the academy 4 days per week.

2 days per week, 9.30am - 4.45pm, studying towards your main qualification.

1 day per week for Maths & Commercial Salon, 9am - 4.45pm*.

1 day per week for English & Commercial Salon, 9am - 4.45pm*.

IF YOU REQUIRE MATHS OR ENGLISH

(Achieved below a 4 at GCSE for either Maths or English - evidence will be required)

You will attend the academy 3 days per week.

2 days per week, 9.30am - 4.45pm*, studying towards your main qualification.

1 day per week for Maths or English & Commercial Salon, 9am - 4.45pm*.

IF YOU HAVE ACHIEVED MATHS & ENGLISH

(Achieved a 4 or above in both Maths or English - evidence will be required)

You will attend the academy 3 days per week.

2 days per week, 9.30am - 4.45pm*, studying towards your main qualification.

1 day per week for Commercial Salon, 9am - 4.45pm*.

COMMERCIAL SALON

WORK EXPERIENCE

Additional to your days of study, it is a requirement of the courses to gain between 3 - 6 hours of industry-related work experience per week. You will need to source your own placement and advise your tutor so that a health and safety checklist can be taken and completed by the workplace before you start your placement.

TUTORIAL

A weekly tutorial will take place between you and your tutor, to track progression, support requirements and learning.

ALL TIMETABLED HOURS REQUIRE A MINIMUM OF 95% ATTENDANCE TO ACHIEVE THE QUALIFICATION

BURSARY FUND

Are you struggling with the costs of full-time education or training?

The 16 - 18 Bursary Fund is here to help.

If you are eligible for the bursary fund, you will be entitled to claim any costs that pay for items relevant to your course - up to a maximum of £1200 each year.

Eligibility criteria will be shared with you when you attend an information session.



Travel:

This fund will assist with travel costs between your home and our academies.



Lunch:

Each day you attend your course, you will receive £2.41 per day to cover lunch costs.



Uniform & Kit:

Any uniform or kit costs which are essential to complete your course can be claimed.

LEARNER SUPPORT SERVICES

Our Learner Support Coaches are there to advise and support young people and their parents/guardians that are facing personal or learning challenges, to support them in successfully completing their training and transition into their chosen career aim.

- Completing consent forms when joining the Academy.
- Financial Support information, completing applications and guidance on next steps.

- Advice, guidance and signposting as required.
- Attendance issues and any issues that arise whilst at the Academy.

SAFEGUARDING

The primary objective of LCG is always the safety and wellbeing of its learners. Its vision has always been about supporting and developing young people to achieve their goals and aspirations. We accomplish this through a combination of study and commercial activities.

We ensure all of our staff are sufficiently trained to deal with any safeguarding concern that may arise. They are supported by dedicated safeguarding leads in all areas and co-ordinated nationally by a Lead Safeguarding Officer.

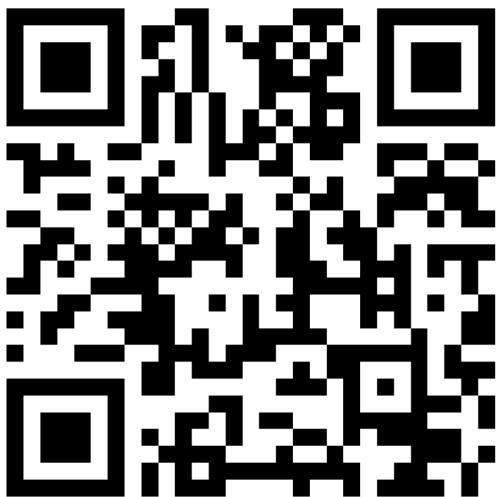
